CONTRACT AGREEMENT

THIS AGREEMENT made this 9th day of January, 2024 between Department of Education, Schools Division of Aurora, located at *Brgy. Bacong, San Luis, Aurora* represented herein by its Schools Division Superintendent, *DANTE G. PARUNGAO, CESO V* of the Philippines (hereinafter called "the Entity") of the one part and Manager, *MYRNA MORENO*, M. MORENO LODGE AND RESTAURANT (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly SUPPLY AND DELIVERY OF CATERING SERVICES FOR THE VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES (PPAS) OF SDO-AURORA FOR FY 2024 EARLY PROCUREMENT ACTIVITY (EPA) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million, Three Hundred Sixty-Four Thousand, Eight Hundred Twenty Pesos (P 1, 364, 820.00).

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as respectively assigned to them in the Conditions of Contract referred to.
- The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - Schedule of Requirements;
 - ii. Technical Specifications:
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of SOne Million, Three Hundred Sixty-Four Thousand, Eight Hundred Twenty Pesos (P 1, 364, 820.00) or such other sums as may be ascertained, M. MORENO LODGE AND RESTAURANT agrees to perform the project SUPPLY AND DELIVERY OF CATERING SERVICES FOR THE VARIOUS PROGRAMS, PROJECTS AND ACTIVITIES (PPAS) OF SDO-AURORA FOR FY

2024 EARLY PROCUREMENT ACTIVITY (EPA) in accordance with his/her/its Bid and the provisions stated in the above mentioned documents in paragraph 2.

- The Department of Education, Division of Aurora agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
- In case of failure to make the full delivery within the time specified above, a penalty of one-tenth (1/10) of one percent for every day delay shall be imposed on the undelivered item/s.
