Bidding is restricted to Filipino citizens/sole proprietorship, partnerships, or organizations with at least 60% interest or outstanding capital belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183. 4.
