INVITATION TO BID FOR
Establishment of Smart Classroom and Procurement of Supplies and Equipment (including delivery, installation, commissioning, testing, and warranty)

1. The **Aurora National High School**, through the **DEPED-ROIII-2025-10-2780** intends to apply the sum of **Php 2,736,167.00** being the Approved Budget for the Contract (ABC) to payments under the contract for Establishment of Smart Classroom and Procurement of Supplies and Equipment (including delivery, installation, commissioning, testing, and warranty) Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The **Aurora National High School** now invites bids for **Smart Classroom Supplies and Equipment** using the *competitive bidding*. Delivery of the Goods is required **within thirty (30) days upon the receipt of Notice to proceed**. Bidders should have completed, at least **two (2) years** from the date of submission and receipt of bids, contracts similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the IRR of RA No. 12009.
 - i) Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.
4. Interested Bidders may obtain further information from **Aurora National High School BAC Secretariat** and inspect the Bidding Documents at the address given below from **Monday to Friday 8:00 am to 5:00 pm**.
5. A complete set of Bidding Documents may be acquired by interested Bidders on **November 10, 2025** from the address given below upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five thousand pesos (Php 5,000.00)**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
6. The **Aurora National High School** will hold a Pre-Bid Conference on **November 20, 2025 9:00 am at Aurora National High School Admin Office** and/or through video

conferencing via <https://meet.google.com/hzy-yijm-ucp>, which shall be open to prospective Bidders.

7. Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat through online submission through the electronic bidding facility of the PhilGEPS as indicated below, **on or before December 02, 2025 9:00 am**. Late bids shall not be accepted.
8. All Bids must be accompanied by a **Bid Security** in any of the acceptable forms and in the amount stated in ITB Clause 16.1.
9. Bid opening shall be on **December 02, 2025 9:30 am at Aurora National High School Admin Office** and/or via <https://meet.google.com/jho-smkj-jnz>. Bids will be opened in the presence of the Bidders' representatives who choose to attend the activity.
10. *Warranty and after sales shall be shouldered by the winning bidder/supplier.*
11. The **Aurora National High School** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 70⁴ of R.A. No. 12009, without incurring any liability to the affected Bidder or Bidders.
